Below is a list of core training services that we are offering through our network of Kee Safety training companies. We offer both general safety and industry-specific specialized training.

IRATA – Rope Access

The use of rope access is now common place around the world, on land and offshore; in cities and on coastal cliffs; on ancient buildings and those of 21st century design. The IRATA training regime delivers high quality rope access technicians working to a safety creed and a proven syllabus. It enables its work force to follow a progressive route of personal development that can culminate in expertise that includes management and supervisory skills, high grade safety and rescue capabilities.



SPRAT

A SPRAT certification provides instant recognition and credibility for the Technicians who carry it, and the companies who invest in it. In turn, companies that hire rope access services will look for the SPRAT certification, and will know you offer the industry's best in technical achievement.



Working at Heights

This course covers the use of fall protection equipment when working at height. It is for personnel who are required to work at height, e.g. roofers, maintenance operatives, surveyors/inspectors and telecom mast/tower climbers. The course provides you with the relevant skills, knowledge and competence to work at height safely using fall protection equipment.

PFPE Competent Inspector Training

This course is intended for people who will be carrying out thorough examinations on Personal Fall Protective Equipment e.g., store personnel, site supervisors, working at height operatives or rope access operatives. Current legislation requires personal fall protective equipment to be thoroughly examined by a complete person.



Anchor Bolt Installation & Testing

This course is designed for personal to be able to install, test, carry out periodic inspection and retesting of anchor devices. It will cover the roles and responsibilities for the system design, installer, inspector, and user. Also, it covers correct installation, testing, certifying, maintenance, and inspection of anchor devices. The course will provide training on documentation to be issued to the client after an installation or periodic inspection.

Harness & Lanyard

This course is for persons required to work in specified locations e.g., MEWP's, Swing stage, Scaffolders, Window cleaners, Lift engineers and Maintenance operatives working on roofs. It provides skills, knowledge and competence to select and use the correct harness and lanyard for the work task.

Kee Line Installation & Testing

On completion the candidate should have a good understanding of PERSONAL FALL PROTECTION, PERMANENT INSTALLATION OF HORIZONTAL LIFELINES. The candidate will be able to demonstrate knowledge, understanding and practical application of the hierarchy of controls as well as PPE equipment selection to be used in conjunction with Horizontal lifelines.

Rescue After a Fall

This course is for personnel who are required to work at height and already have working at height training with fall protection equipment. It has been designed to provide you with the skills, knowledge, and competence to undertake a rescue of an operative after a fall and is suspended by their lanyards. The course covers rescuing a casualty from fall arrest equipment after a fall using a prepacked rescue equipment.

GWO – Full Suite Module Package

The Global Wind Organisation (GWO) provides the training standards for those hoping to work in the wind industry. Our training providers offer both initial training and refresher training. Additional GWO BST modules include working at heights, manual handling, fire awareness, and first aid.



Confined Space & Difficult Access Training

One day Low/Medium Risk Confined Space training course consisting of both theory and practical exercises relating to working in confined spaces. This course will provide delegates with a thorough understanding of confined spaces, associated dangers and the ability to enter, work and leave safely by horizontal and / or vertical entry in line with the Occupational Health and Safety code.

MEWP Course

This course is for personnel who are required to operate an MEWP and already have working at height training with fall protection equipment. It has been designed to provide you with the skills, knowledge, and competence to undertake a pre-use check of scissor and boom lift style MEWPs, identify types and components of different MEWPs, and to operate an MEWP safely.
